Additional Notes:

All exhibitors must supply the SCMA with a certificate of liability insurance in the amount of \$1,000,000 naming the SCMA, the Sheraton San Diego Hotel & Marina, its owners, its operators and Sheraton Hotels & Resorts Worldwide as additional insured. The coverage must be for July 19-July 28, 2009. This must be done before you move-in!!!

All exhibitors must have a copy of their current California Resale License available in their booth.

Any exhibitor using helium, a flame or cooking device must have a fire permit - see Exhibitor Handbook.

Boat exhibitors on land, please tape all gas caps before you come to the show and disconnect all batteries.

Parking – the Sheraton will charge \$10.00/day on show days with no in/out privileges.

Exhibitors may also purchase a 4-day parking pass for \$28.00 at a paved parking lot that does provide in/out privileges (as long as parking spaces are still available). Exhibitors will not be charged for parking while unloading and loading during move-in and move-out.
